# 1 Purpose

The purpose of this release note is to provide a brief description of the Participation Data Specification v3.2. This release note details the location of the specification, highlights resolved and outstanding issues, and also provides links to supporting documentation.

## 2 Introduction

The Participation data group has been used extensively in the National E-Health Transition Authority (NEHTA) structured document templates (SDTs). Participations are meaningful only within the context of an information model where they record context-specific relationships between participants and events.

## 3 Release Log

This specification is released with known issues that will be resolved in the next published version. Areas requiring resolution are recorded in the APPENDIX A: KNOWN ISSUES section of the specification.

This version (3.2) of the Participation Data Specification has been revised to support multiple entity identifiers. The following significant changes have been made:

- The constraint that Entity Identifier is Single has been relaxed.
