# 1 Purpose

The purpose of this release note is to provide a brief description of the Miscellaneous Detailed Clinical Models Specification v1.0. This release note details the location of the specification, highlights resolved and outstanding issues, and also provides links to supporting documentation.

# 2 Introduction

The Miscellaneous Detailed Clinical Models Specification consists of several data groups.

The Clinical Synopsis data group is to be used by the healthcare provider to describe additional information such as interpretation and the subject of care's understanding of the health care event that are not captured by other structured or unstructured information components pertinent to that health care event.

The Recommendation Data Group is to be used to capture a recommendation, such as from a referee or specialist to a recipient health care provider regarding the management of the patient.

The Exclusion Statement Data Group is to be used to positively record the absence or exclusion of any clinical findings or evaluations within the health record.

The Record Review Data Group is to be used to record that a healthcare provider has reviewed a specified part of a health record, including that it was reviewed and left unaltered or that it was reviewed and updated.

The Referral Detail Data Group is to be used to record specific information about the clinical referral.

The Medical History Item Data Group allows recording of an entry in a medical history when it cannot be determined whether the entry is a Procedure or is a Problem/Diagnosis.

## 3 Release Log
