

# Advance Care Document Custodian v1.1 Release Note

## **Release rationale**

## Advance Care Document Custodian

This incremental release of the *Advance Care Document Custodian* end product (formerly *Advance Care Directive Custodian*) introduces the *Conformance Profile* as a new product component, and updates the *Template Package Library*.

**Note:** With this release, the 'Common - Consumer Entered Information - PCEHR Conformance Profile v1.3' will be archived and the Advance Care Directive Custodian Conformance points that are in the 'Common - Consumer Entered Information - PCEHR Conformance Profile' will be reflected in this new profile, titled Advance Care Document Custodian – My Health Record Conformance Profile v1.0.

### **Conformance profile**

The My Health Record programme has identified specific use cases where the author of this type of document may not have an individual healthcare identifier (IHI). For example, a care agency worker may add an advance care document to the My Health Record system on behalf of a consumer. The conformance profile allows for the use of an alternative identifier in these circumstances.

### Template package library

The updated *Template Package Library* contains all template packages available for the *Advance Care Document Custodian* document type and can be identified using the template package ID, given in the table below.

The template package has been updated to allow the use of a care agency employee identifier instead of an IHI.
