### Summary

#### **EP-1597:2014 Australian Medicines Terminology v3 – Common v1.0.1**

This end product contains product components that are common to the AMT v3 model.

#### **Release rationale**

This release includes:

- The *Australian Medicines Terminology v3 Model Diagram*, which represents the conceptual model of AMT. The model reflects the Stated Form of AMT and has been created using a combination of UML syntax and the *SNOMED CT Diagramming Guideline*. It has been modified since the release of AMT v3 Beta in February 2013 and is the result of feedback received from stakeholders. The AMT v3 release data will be compliant with this model.
- An update to the *Australian Medicines Terminology v2 to v3 Migration Guide* to incorporate recent changes to the AMT v3 Model. It describes the key differences between the AMT v2 and v3 and is relevant for those currently using AMT v2 who will need to migrate to AMT v3.
