## 1.1 Purpose

The eHISC Binary Software is licensed under the eHISC Binary Software - Software Licence Terms and Conditions (included in the eHISC Binary Software Package, downloadable from the NEHTA website). The eHISC Source Code is licensed under the NEHTA Production Disclaimer (included in the eHISC Source Code Software Package, downloadable from the NEHTA website). The purpose of this document is to specify the third-party software licence terms for third-party software used in both eHISC Source Code and eHISC Binary Software.

The intended use of this document is to make implementers aware of the extent of third-party software used in the eHISC software with which they must comply. Section 4 of this document also lists the NEHTA library products used in eHISC software.

## 1.2 Scope
