### Release rationale

#### Updated conformance profile

This release introduces updates to the conformance profile for eHealth Prescription and Dispense View documents, as mandated by approved change request CCB-0314. This change request mandated that the rendering of eHealth Prescription and Dispense View documents conforms to the *PCEHR Prescription and Dispense View Presentation Guide*, in alignment with advice and guidance already provided to and adopted by the sector.

#### Template package library

The *Template Package Library* has been introduced as a new product component. It contains the template package aligned with *eHealth Prescription and Dispense View PCEHR Conformance Profile*<sup>1</sup>:

These new conformance requirements expand on and replace the conformance requirement for digital signatures in the *PCEHR Prescription and Dispense View - PCEHR Conformance Profile v1.1*<sup>6</sup>. With version 1.2 of the *PCEHR Prescription and Dispense View - PCEHR Conformance Profile* this conformance requirement has been removed.

## EP-1361:2013 PCEHR Prescription and Dispense View v1.1

Release note: NEHTA-1360:2013, 26 June 2013

### Summary

The PCEHR Prescription and Dispense View will be provided as a Clinical Document Architecture (CDA) document by the Personally Controlled Electronic Health Record (PCEHR) system.

The individual will be able to retrieve PCEHR Prescription and Dispense View CDA documents through their PCEHR, and healthcare providers with access to the individual's PCEHR will be able to access these same documents using the PCEHR system's business-to-business gateway. The individual's PCEHR Prescription Record and PCEHR Dispense Record data items stored in the PCEHR system serve as source data for the individual's PCEHR Prescription and Dispense View.

The PCEHR Prescription and Dispense View CDA specifications form part of the foundational set of specifications to support the development of an individual's PCEHR.

### Release rationale

This release will:

- Assist clinical information system vendors to render and display the Prescription and Dispense View in a consistent manner while taking advantage of the safety assessment that has been carried out in this guide's development. All the mandatory guidance points will form the basis of compliance audits of the implementation in vendor software.
- Provide clinical information system vendors with a style sheet that is aligned to and conformant with the *PCEHR Prescription and Dispense View Presentation Guide* that they can integrate into their products. This supersedes version 1.0.1 which was a limited release made available to the vendor panel on 21-March-2013.
