### Scope

The four key components of the Health Record Overview are:

• New Documents: This contains a listing of documents that have been uploaded to the My Health Record for the current patient *since the last shared health summary was uploaded to the My Health Record*. It lists shared health summaries, event summaries, discharge summaries, ereferrals, specialist letters and personal health summaries.

- Recent Documents: This contains a list of documents that have been uploaded to the My Health Record for the current patient *within the last 12 months*. It lists shared health summaries, event summaries, discharge summaries, e-referrals, specialist letters and personal health summaries.
- Shared Health Summary: This is an existing specification for the My Health Record and contains information such as current and past medical history, medications, allergies and adverse reactions and immunisations.
- Links to Other Documents: This provides links to views and other records available in the current patient's My Health Record; for example, advance care planning documents and prescription and dispense records.
