Release rationale

End product name change

This end product has been renamed to *Healthcare Identifiers Service Support Documents* to avoid confusion with the DHS Medicare Healthcare Identifiers Service and to provide a more accurate description of its contents.

New B2B web service: Create Verified IHI for Newborn

Through its regular continuous improvement cycle, the Healthcare Identifiers (HI) Service has made available a new B2B web service for requesting the HI Service to create a verified IHI for a newborn child. This release enables software to be designed and tested for the appropriate use of this new B2B web service. The HI conformance requirements for connecting software have been updated to reflect this new functionality.

The Department of Human Services (DHS) has released the following technical specification:

TECH.SIS.HI.26: Create Verified IHI for Newborn

To support the release of the above web services, the following use case has been introduced:

UC.011: Request verified IHI for newborn

This is an optional use case and there is no obligation for existing software to adopt the new web service.

The conformance requirements document has been updated to include this new use case and associated requirements.

Guide for healthcare provider organisations

This release includes a new guide for healthcare provider organisations who need to request the assignment of individual healthcare identifiers from the Healthcare Identifiers (HI) Service for newborns born under their care, using the Create Verified IHI for Newborns web service.

It covers principles relevant to individual healthcare identifiers for newborns, provides guidance for developing related organisational policies and processes, and provides details of associated workflows and business processes to ensure the service is used as intended.

This guide is intended to help organisations make effective use of the HI Service according to the National Safety and Quality Health Service Standards.

Release rationale

Through its regular continuous improvement cycle, the HI Service has made available a set of new B2B web services. The HI Conformance Requirements for connecting software has been updated to reflect the new functionality available in the HI Service.

Information for vendors

This release enables software to be designed and tested for the appropriate use of new B2B webservices for searching/validating HPI's in the HI Service (instead of the HPD).

Department of Human Services (DHS) have released technical specifications for the following HI B2B web services:

TECH.SIS.HI.32	Search for Provider Organisation Details
TECH.SIS.HI.33	Search for Provider Individual Batch Asynchronous

To support the release of the above web services, the following use cases have been introduced:

UC.131	Search for HPI-I's in the HI Service
UC.306	Get HPI-O status

These are optional use cases and there is no obligation for existing software to adopt the new web services. Implementers should note that software using the new webservices cannot assume HPI-Os and HPI-Is returned from the HI Service will be active. For this reason, HI software should build in the functionality to track HPI status over time for the correct management of these HPIs.
