Release rationale

The eHealth integration toolkits are a collection of integration tools and sample code resources available in both .NET and Java. The sample code and integration tools are used within the eHealth Reference Platform, forming part of the code library for tools and simulators. Access to sample code and the eHealth Reference Platform's online simulator services is supported by suitable right-to-use licenses and terms and conditions regarding the eHealth Reference Platform.¹ (The eHealth integration toolkits are available from http://www.nehta.gov.au/implementation-resources/ehealth-reference-platform.)

The PCEHR Integration Toolkit contains libraries for B2B connectivity to the PCEHR service, providing sample code for all operations as well, as the schemas used and sample SOAP request and response messages.

Note that the product components included in this release were previously released on nehta.gov.au as part of the end product PCEHR B2B Gateway Services. See page 2 for a mapping of the relevant product component identifiers.
