### Licence Terms

#### 1. Defined Terms

In this Test Licence:

**IQ Rules** means the software, technical specifications, documentation or other Agency content relating to Agency's Information Quality Rules which operates with Agency's Clinical Package Validator and My Health Record template packages to test software conformance to the My Health Record System Operator requirements.

**Software Application** means a software application or web service developed by You.

#### 2. Licence

Subject to all the terms of this Test Licence, Agency grants **You** (meaning the individual or entity exercising the rights granted under this Test Licence) a world-wide, royalty-free, non-exclusive, non-transferable, revocable licence to use and copy the IQ Rules solely for Your internal purpose of developing and testing Your Software Applications.

Agency may, without limitation, make the IQ Rules available to you by making them generally available on an Agency web site and revise the IQ Rules during the term of this Test Licence from time to time. It remains Your sole responsibility to check that You are using the most current set of IQ Rules released by Agency together with the most current version of the Clinical Package Validator product licensed by the Agency.

For avoidance of doubt, the licences granted in this clause explicitly exclude any right to publish, distribute, sub-license or transfer the IQ Rules or any rights under this Test Licence to any third party. All rights not specifically granted in this Test Licence are reserved to Agency.

This Test Licence is granted without a fixed term but is subject to termination by Agency for any breach or non-compliance by You with any term or condition of this Test Licence or in event that You become unable to pay your debts as they fall due or suffer any other act of insolvency in any jurisdiction.
