Release rationale

This release of the My Health Record Overviews, Guides and Conformance Material have been updated to align with new capabilities being introduced to the My Health Record Release 11.2 in March 2021. This update includes the following:

- Support for Transport Layer Security (TLS) Protocol Version 1.2
- Removal of support for TLS Protocol Version 1.0
- Removal of support for TLS Protocol Version 1.1

The change in TLS Protocol support will not affect the current vendors immediately, and timely engagement will occur in the near future to specify when the change will be enforced. However, all new vendors will need to conform to updated conformance requirements according to the My Health Record Release 11.2.
