These technical specifications enable developers to connect applications to the My Health Record system via the FHIR® Gateway. They describe API requests and responses, data mapping between CDA implementation guide fields and Fast Healthcare Interoperability Resources (FHIR®), and the error scenarios and associated error codes for all APIs. It is intended for use by FHIR® API consumers to understand the API signature exposed by the My Health Record system and the 'my health App'.

Release rationale

The updates reflect changes made to the current API (v2.1.0) of the My Health Record FHIR gateway during release 13. These includes:

- New API (getXMLView) service call that provides a mechanism for conformant external systems to retrieve a series of predefined views for a consumer's digital health record that can collate data from across documents within record.
- New API service call that allows retrieval and download of the COVID-19 Digital Certificate PDF file into iOS and Android digital wallets.
- New API service call to retrieve immunisation history that can be used as a proof of vaccination.

This release added new APIs to retrieve XML views and the immunisation history in version 2.0.0 of the My Health Record FHIR® Gateway. Besides that, this release also added a new API to retrieve and download the COVID-19 Digital Certificate into digital wallets. The API specification, data mapping and error mapping documents of My Health Record FHIR® Gateway are updated.

This work was to align the documents to Release R12.1, R13 of the My Health Record and 'my health' app v1.0.0.

	Version 2.0.0 of the My Health Record FHIR® Gateway introduces two major improvements:
	1. It leverages the MyGov authentication hub which allows mobile app users to use their email address or mobile number to sign into My Health Record.
	2. It provides the technical improvements to the internal architecture of the FHIR® APIs to enhance performance but leaves the functional behaviours and the request and response structures unchanged. The technical improvements were first introduced in v1.3.0 for selected APIs; this version extends the improvements to the rest of the APIs.
