These technical specifications enable developers to connect applications to the My Health Record system via the FHIR® Gateway. They describe API requests and responses, data mapping between CDA implementation guide fields and Fast Healthcare Interoperability Resources (FHIR®), and the error scenarios and associated error codes for all APIs. It is intended for use by FHIR® API consumers to understand the API signature exposed by the My Health Record system and the 'my health App'.

### Release rationale

The updates reflect changes made to the current API (v2.2.0) of the My Health Record FHIR gateway for Covid Change 3 and MyMedicare. These includes:

- New type of immunisation statement that includes COVID and Flu
- New error codes for Get Immunisation Statement
- New view type and version that includes MyMedicare
- New error codes for Get XML view
