

Aged Care Transfer Summary Release Note

The Aged Care Transfer Summary (ACTS) is a digital solution using My Health Record that facilitates access to crucial health information relating to an aged care resident to support clinical hand-over when an individual is transferred from an aged care setting to acute hospital care.

The ACTS implements three new record types into the My Health Record system for the sharing of residential health information from Residential Aged Care Facilities (RACFs) systems. These include a Residential Care Transfer Reason, Residential Care Medication Chart and Residential Care Health Summary.

A Residential Care Transfer Overview consolidated view is also available within the My Health Record system containing information relevant to the receiver of the aged care resident, with a summary of the most current health information available within My Health Record.

Release rationale

The ACTS has been developed in response to the Royal Commission into Aged Care Quality and Safety Final Report (March 2021) – Recommendations 68 & 66.

Benefits of the ACTS in My Health Record:

- Improved and timely information sharing between healthcare providers, in transition of care scenarios (between RACFs)
- Provides a central source of information for relevant healthcare providers, residents, and their carers via My Health Record

This is an incremental release of ACTS specifications, where we have removed the HPI-I relaxed template packages from 'Aged Care Transfer Summary – My Health Record Template Package Library' bundle.

The Connecting Australian Healthcare – National Healthcare Interoperability Plan 2023-2028 is to deliver a connected healthcare system. Identity is the priority area in the Interoperability Plan. An action under Priority 1 – Identity, is to review and adopt national healthcare identifiers (action 1.1) and promote

healthcare organisations' implementation of Healthcare Provider Identifiers – Individual (HPI-I) (actions 1.5). HPI-Is are a mandatory requirement for My Health Record.

Clinical Information Systems that view the My Health Record system will need to ensure the new document types can be accessed by their users. This will typically involve ensuring the new documents are selectable document types on the document list screen. We recommend these documents are included by default.
