They describe API requests and responses, data mapping between CDA implementation guide fields and Fast Healthcare Interoperability Resources (FHIR®), and the error scenarios and associated error codes for all APIs. It is intended for use by FHIR® API consumers to understand the API signature exposed by the My Health Record system and the 'my health App'.
