In this Licence:

**Clinical Package Validator** means the software, technical specifications, documentation or other Agency content relating to Agency's Clinical Package Validator which operates with the Agency's Information Quality Rules and My Health Record template packages to automate some of the tests needed to assess conformance of clinical documents and clinical packages with My Health Record System Operator requirements.

**Software Application** means a software application or web service developed by You.

#### 2. Licence

Subject to all the terms of this Licence, Agency grants **You** (meaning the individual or entity exercising the rights granted under this Licence) a world-wide, royalty-free, non-exclusive, non-transferable, revocable licence to use and copy the Clinical Package Validator solely for Your internal purpose of developing and testing Your Software Applications.

Agency may, without limitation, make the Clinical Package Validator available to you by making them generally available on an Agency web site and revise the Clinical Package Validator during the term of this Licence from time to time. It remains Your sole responsibility to check that You are using the most current version of Clinical Package Validator released by Agency together with the most current versions of the Information Quality Rules and My Health Record template packages licensed by the Agency.
