1. Release 12.2 – SVT Deployment Schedule

My Health Record Release 12.2 will be deployed into the My Health Record Software Vendor Test (SVT) environment after **5:00 PM (AEST) on Wednesday 28 July 2021**. All functionality of the SVT environment will remain available. Please note, the environment upgrade is outside of the advertised available hours for the SVT environment. Please email the SVT inbox (MyHealthRecord.SVT@accenture.com) between 29 - 30 July if any issues are encountered.

2. Release 12.2 – Summary of Changes

Release 12.2 of the My Health Record (MHR) system is focussed on delivering functional and security updates and includes new immunisation enhancements. This document outlines the work packages, PBIs and defects that vendors should be across in preparation for the deployment.

2.1 Immunisation Enhancements Phase 4

Immunisation Enhancements Phase 4 introduces additional key functionalities for users in relation to the information available in My Health Record from the Australian Immunisation Register. No changes are required to vendor products to support this work package.

Services Australia will now be sending information related to COVID-19 proof of vaccination through to the My Health Record system via a new COVID-19 Digital Certificate PDF on-demand service. This PDF can be used by consumers via the National Consumer Portal (NCP) to provide evidence that they have received both doses of COVID-19 vaccination.

This new functionality will be integrated within the existing Record Home view and Immunisation view within the NCP. It will also be retrievable via the existing myGov quick link. The My Health Record mobile gateway v2.0.0 getImmunisationStatement API will be utilised, which will allow for retrieval of the new COVID-19 Digital Certificate PDF as well as the existing Immunisation History Statement PDF.

On Record Home view and Health Record Overview within the NCP and National Provider Portal (NPP), the COVID-19 vaccine second dose due date alert has been enhanced to provide a date range for when the consumer should receive their second dose. The dates are calculated based on the minimum and maximum recommended interval for the second dose of the vaccine brand received for the first dose. This information provides consumers and providers a better understanding as to when the next COVID-19 vaccine is due.

Note: Mobile vendors who wish to complete Notice of Connection (NOC) testing for the new functionality available via the mobility gateway should please contact the SVT Team at MyHealthRecord.SVT@accenture.com for updated NOC test cases and NOC test data.

2.2 Patches

As part of Release 12.2, patches will be deployed to the Oracle HTTP Server to maintain the security posture of the MHR system. The patch release notes from Oracle do not suggest that there will be any impact to vendors, however there is still a risk that these patches may impact how vendors interact with the My Health Record system. Therefore, it is recommended that vendors perform connectivity testing in SVT post go-live.

2.3 NASH Improvements

The NASH Improvements work package involves replacing the current Medicare PKI certificates with NASH SHA-2 certificates in the My Health Record System for all transactions. Vendor HPI-O and CSP SHA-1 and SHA-2 certificates should not be impacted by this update and can continue to be used as usual. Both NASH SHA-1 and SHA-2 certificates will remain supported in the SVT and Production environments.

At this time, no immediate action is required by vendors and the appropriate communication will be sent regarding the decommissioning of NASH SHA-1 certificates which is currently planned for March 2022.

2.4 OCA Updates

As part of Release 12.2, a technical OCA (Oracle Certified Associate) change will be deployed to allow the MHR system to support vendor NASH SHA-1 HPIO and CSP certificates with the old Services Australia SHA-1 chain of trust as well as the new SHA-1 OCA (2026). No changes are required on the vendor end to support this change. Vendors can perform connectivity testing against this change post SVT go-live on 28 July 2021.

3. Issues in Release 12.2

As per the table below, there was a defect impacting Immunisations view via B2B that has now been resolved as part of Release 12.2.

Defect ID	Summary	Status	Impact on Vendors
HDM-3299	Hyperlinks are not showing on the documents for the immunisations view for B2B.	Resolved	The hyperlinks on the SHS (Shared Health Summary) and EVS (Event Summary) document were not available for the Immunisations view. The workaround provided was to access via the links at the top of the page.
