## 1. Release 12.2.1 – Production Deployment Schedule

My Health Record Release 12.2.1 will be deployed into the My Health Record Production environment **on Thursday 30th September 2021**. All functionality of the Production environment will remain available.

## 2. Release 12.2.1 – Summary of Changes

Release 12.2.1 of the My Health Record (MHR) system is focussed on delivering functional and security updates including a change to the notifications and on screens alerts in National Consumer Portal (NCP), the National Provider Portal (NPP) and B2B and International COVID-19 Vaccination Certificate (ICVC) Information Text. This document outlines the patches and defects that vendors should be across in preparation for the deployment.

### 2.1 Patches

As part of Release 12.2.1, patches will be deployed to the Oracle HTTP Server to maintain the security posture of the MHR system. The patch release notes from Oracle do not suggest that there will be any impact to vendors, however there is still a risk that these patches may impact how vendors interact with the My Health Record system.

### 2.2 Notifications and On-Screen Alerts

A change will be made to the notifications and on-screen alerts displayed in the NCP Record Home, and Immunisations View, NPP Health Record Overview, and Immunisations View and B2B Immunisations View. The change will include the following:

- Remove pending overdue second dose notification once there are two vaccines of the same brand or mixed brand regardless of the interval.
- Remove due second dose on-screen alert from displaying as soon as the COVID-19 status is complete.
- Remove the overdue second dose on-screen alert from displaying as soon as the COVID-19 status is complete.
- Remove display of partial COVID-19 status. *Services Australia indicated that this status will be removed from the AIR status service.*

Vendors are advised to perform connectivity testing and functional testing of the B2B Immunisations View following the completion of Release 12.2.1.

### 2.3 ICVC Information Text

Services Australia is currently working on developing an International COVID-19 Vaccination Certificate (ICVC) for use when someone is wanting to travel overseas. A change will be made to add the information text in the My Health Record where the Immunisation History Statement (IHS) and COVID-19 Digital Certificate (CDC) can be retrieved. This is to advise healthcare recipients and their representatives on how they can obtain the International COVID-19 Vaccination Certificate (ICVC).
