## 1. Release 13 – Production Deployment Schedule

My Health Record Release 13 will be deployed into the My Health Record Production environment **on Thursday 25 November 2021**. All functionality of the Production environment will remain available. There is still a risk however, that there may be some impact with how vendors interact with the My Health Record system. Therefore, **it is recommended that vendors perform connectivity testing in Production on Thursday, 25 November 2021**.

## 2. Release 13 – Summary of Changes

Release 13 of the My Health Record system is focused on delivering functional and security updates including the COVID-19 Dashboard, immunisation history statement and COVID-19 digital certificate HTTP code adjustments. This document outlines the functional updates, patches, and defects that vendors should be across in preparation for the deployment.

### 2.1 COVID-19 Dashboard

A change will be made to introduce a new COVID-19 dashboard in My Health Record. This brings together, in one place, information from the Australian Immunisation Register and My Health Record related to consumers' COVID-19 vaccination journey. It can be used as a quick reference for consumers when answering questions before a vaccination or to get proof of vaccination.

The COVID-19 Dashboard will include:

- Information from the Australian Immunisation Register and documents in My Health Record that may be useful for a consumer's COVID-19 Vaccinations.
- Easy access to key information such as finding a vaccine clinic, booking vaccination appointments, status of doses, and proof of vaccination.
- Health information that may need to be provided when a consumer is receiving their COVID-19 vaccination.
- Recent vaccinations history.
- Recent COVID-19 test history.

### 2.2 Addition of Cultural and Linguistically Diverse (CALD) Information

An update will be made to the Record Home, and Profile pages within the National Consumer Portal (NCP). CALD information (preferred language and country of birth) can be added under the background section on the Profile page and displayed under the personal information section on the Record Home page.

### 2.3 CDC Download to Mobile Wallet (Android & iOS)

As part of Release 13, consumers will now have the ability to download their COVID-19 digital certificate (CDC) from the NCP to the digital wallet available on their mobile devices. The CDC can be retrieved from the following pages

## 2.4 Immunisation History Statement and COVID-19 Digital Certificate HTTP Code Adjustments

A change will be made to the HTTP response codes for immunisation history statement and COVID-19 digital certificate services. This change is to resolve an issue identified where the current error response codes were not meaningful to consumers when contacting customer support given that the error message does not provide enough information to understand the problem.

## 2.5 PBIs

As part of Release 13, PBIs will have no impact on vendors.

## 2.6 Defects

The following defects will be addressed as part of Release 13.

## 2.7 Patches

As part of Release 13, patches will be deployed to the Oracle HTTP Server to maintain the security posture of the MHR system. The patch release notes from Oracle do not suggest that there will be any impact to vendors, however there is still a risk that these patches may impact how vendors interact with the My Health Record system. Therefore, it is recommended that vendors perform connectivity testing post go-live.
