# **Production Deployment Schedule**

My Health Record Release 24.5.0 will be deployed into the My Health Record Production environment on **Wednesday 9 October 2024**. All functionality of the Production environment will remain available.

# **Summary of Changes**

Release 24.5.0 of the My Health Record system is focused on delivering functional and security updates. This includes:

- Aged Care Support at Home
- Emergency Contacts (NCP Parity)
- Defects
- Patches
- Problem fixes

# **Aged Care Support at Home**

The purpose of this work package is to allow for Aged Care Support Plans (assessment and support plans) information to be made available in My Health Record (from the My Aged Care system) so that relevant healthcare providers can view Aged Care Support Plan. The inclusion of Support at Home - Aged Care Support Plan information in My Health Record will reduce the need for paper document and will provide a more efficient way to make information available from the My Aged Care system to different healthcare settings (e.g.: General Practitioner, Hospital, Emergency Department).

As part of this work package, changes will be implemented to doesPCEHRExist and removeDocument B2B APIs to facilitate access for Conformant Repository Provider (CRP) consumers. Additionally, a new registerDocument B2B API will be developed to enable document registration in My Health Record. The getDocumentCRP API, which retrieves clinical documents from a CRP, will also be updated to enable the retrieval of DocumentSupportPlans from Department of Health and Aged Care.

## Viewing Aged Care Support at Home document type in my health app

The purpose of this work package is to make an Aged Care Support at Home document type available in the health app for viewing and sharing as per other document type functionality.

## **Emergency Contacts (NCP Parity)**

The purpose of this work package is to closely align the functionality of the my health app (or other app connected to the Fast Healthcare Interoperability Resources (FHIR) Gateway) with the National Consumer Portal (NCP). Bringing my health app in line with NCP functionality for consumers to add, view, edit and remove emergency contact (Emergency Contact/Carer/Next of Kin). It is anticipated that these changes will remove the need for consumers to only utilise the NCP web channel for emergency contacts. In this work package, new PUT/GET EmergencyContact Mobility FHIR 4.0.1 compliant APIs will be developed to support the read and update of emergency contacts.

#### **Defects**

There are no vendor system related defects being addressed as part of Release 24.5.0.

#### **Patches**

As part of Release 24.5.0, patches will be deployed to maintain the security posture of the My Health Record system. The patch release notes from Oracle do not suggest that there will be any impact to vendors. However, there is still a risk that these patches may impact how vendors interact with the My Health Record system.

#### **Problem Fixes**

Problem fixes being delivered as part of Release 24.5.0 will have no impact on vendors.
